Oklahoma Cup less than 30 teams participated. Net income from the tournament should be available at the November meeting.

Lake Overholser Complex: Wes Gray for the city of OKC called me today notifying me that Frontier Country was the successful applicant to manage the complex. We cannot put a club at the fields until the existing adult league finishes their spring season, approximately May 2011. At this time FCSA would like to place one of the recognized FCSA members at those fields. Clubs need to submit their request to use the fields to the FCSA office in writing. The fields must be maintained in accordance with the Oklahoma City agreement. It will likely take the summer to get the fields in reasonable condition for the youth games.

Academy Program: The boy's academy program did not have enough clubs participating to schedule the games through the league. Coaches need to schedule games/scrimmages with other teams/clubs to ensure that these players get the playing time they deserve. The girl's academy program had just enough to schedule. The schedule is out and will see how games are going. Thanks to the clubs that made the girl's academy bracket possible. May be possible to schedule a few of the Southlakes teams with the Academy league next year; this springs season was questionable but not ruled out.
