**THIS FORM MUST BE COMPLETED AND E-MAILED, FAXED OR MAILED TO FCSA. FCSA MUST RECEIVE THE COMPLETED FORM ON OR BEFORE TEN (10) DAYS BEFORE THE ORIGINAL PLAY DATE; OR, FOR GAMES WHICH ARE CLUB CANCELLED DUE TO WEATHER, FCSA MUST RECEIVE THIS COMPLETED FORM WITHIN TEN (10) DAYS AFTER THE ORIGINAL PLAY DATE.**

**ANY TEAM WHO IS REQUESTING THAT A GAME BE RESCHEDULED FOR ANY REASON NEEDS TO REVIEW THE OPPOSING TEAM'S ORIGINAL SCHEDULE AND HAVE AT LEAST THREE REASONABLE RESCHEDULE DATES AVAILABLE FOR CONSIDERATION WHEN CONTACTING A TEAM TO RESCHEDULE A GAME. UNLESS THE GAME IS BEING RESCHEDULED FOR A TOURNAMENT OR FOR ACT/SAT TESTING, THE TEAM WHO IS BEING ASKED TO RESCHEDULE A GAME SHOULD REFUSE TO CHANGE A SCHEDULED GAME UNTIL A RESCHEDULED DATE AND TIME IS AGREED UPON BY BOTH TEAMS AND THE HOME CLUB SCHEDULER.**
